## Sustainability 3 Legged Stool




If all three legs are not equal, the stool will not stand = not sustainable

- Not just ECO
- Not just feel good CSR
- Not tree-hugging



#### Environmental

### MSME Role in Support of Environment

### Enabling Business Economic Development

  - if the enabling environment lets them!
- Big problem currently
  - so tied up in paperwork, realising these bigger goals tough.
- Streamlining business regulations
  - provide opportunities for many more SMEs keen to help achieve these goals.
  - support resource owners manage their own small businesses
- Monthly 13 different taxes and fees to file!
  - little time for much else like business growth
- Need to make things easier for SMEs.
- Need an enabling environment that is enabling not prohibitive!
